## Relief activities

To the best of my knowledge there has been very little of any of these offered to anyone in the area. I can think of two examples where people have sought housing assistance and been give substantial (\$50,000 I believe) grants to replace houses that didn't exist. Some residents of Cann River and Club Terrace are still living in temporary accommodation.

The East Gippsland Shire has no effective presence in far East Gippsland. BRV looks like it's hopelessly compromised by Covid, primarily but also the need to work with the Shire. No information about any of these matters has reached my community, Cabbage Tree Creek, except that which I've sought and distributed as Secretary of the local Hall Committee.

## **Recovery activities**

There have been no community meetings in far East Gippsland outside of Malacoota. BRV and the Shire are pushing through with community recovery committees without informing the community about any of it. I tried to organise 2 meetings with BRV and the Shire but both were cancelled owing to covid. On-line meetings are not an option here as the population isn't very computer savy, there is no reliable mobile reception in Cabbage Tree Ck and not enough people have good satellite coverage. It's particularly anoying because they parrot their 'community led recovery' mantra whilst barely attempting to engage with the community.

In this vacuum he one group that's making hay (wooodchips) while the sun shines is the logging lobby. They're doing great out of roadside clearing ... subsidized to ship logs, mostly for woodchips and a few for sawmills. Down on the Cape Conran - Cabbage Tree Road, as I type, they're logging Potaroo habitat. No EIS, as usual, despite the last high court decision. AND there's practically no sawlogs in it. To judge by the piles it's about 5 truckloads to the chipper for every 1 of sawlogs. The drive down to Conran is increasingly a view of devastation. A pity when that's the major tourist asset in the area and the best hope for a town like Cabbage Tree to have a long term economic future.
